
INTERGOVERNMENTAL COOPERATIVE PURCHASING AGREEMENT PORT OF TACOMA



PURSUANT TO CHAPTER 39.34 RCW and to other provisions of law, the King County Directors' Association Purchasing Department, hereinafter called "KCDA", and the following named public agency of the State of Washington, PORT OF TACOMA hereinafter called "the public agency", hereby agree to cooperative governmental purchasing upon the following terms and conditions:

- KCDA in contracting for the purchase of goods and service for the member public school districts, agrees to contract also on behalf of the public agency, to the extent permitted by law and agreed upon by the parties.
- KCDA will contract for the purchase of goods and services according to the laws and regulations governing purchases by and on behalf of the public school system of the State of Washington. The public agency accepts responsibility for compliance with any additional or varying laws and regulations governing purchases by or on behalf of the public agency in question.
- The public agency reserves the right to contract independently for the purchase of any particular class of goods or services, with or without notice to KCDA.
- KCDA reserves the right to exclude the undersigned public agency, or any class containing the undersigned public agency, from any
 particular purchasing contract, with or without notice to the public agency.
- 5. The public agency agrees to pay for goods and services as billed by KCDA upon completion of transfer of goods per normal terms as established by KCDA. Any additional expense incurred by KCDA in regards to any transaction for the public agency shall be paid by the public agency.
- This agreement shall continue in force until cancelled by either party, which cancellation may be effected with or without notice to the other party.
